Re: CRF Grant Agreement for the maintenance of the CTNS rat model

Dear Olivier:

The Cystinosis Research Foundation is pleased to announce that after a review by the CRF Scientific Review Board, your request for funds to house the rat colony in Zurich has been approved.

CRF will support the maintenance of the rat colony for two years. The total amount of the grant will be \$40,000. CRF agrees to make two payments once the Agreement is signed; one payment of \$20,000 on or before May 1, 2023 and the second grant payment of \$20,000 made after receipt of the progress reports listed below.

In return for the two-year grant support, please confirm that you will agree to the following terms:

1. A progress report at the end of year one (April 30, 2024) and at the end of year two (April 30, 2025) that reports on the efforts of Jackson Labs to establish a colony and to permanently host the strain.
2. A progress report at the end of year one (April 30, 2024) and at the end of year two (April 30, 2025) that describes how the colony is being used (i.e. is research taking place using the animals either locally or via providing animals to other researchers). Please include a list of the researchers who receive the animals from you.
3. We request that you publicize and share the existence and availability of the animal model in the cystinosis research and scientific community. In addition, we request that you acknowledge CRF's support in developing the rat model and maintaining the colony when the animals are utilized.

We recognize that the cost to maintain the rat model is expensive and we are pleased to support the colony so that animals can be sent to other researchers for their protocols and that breeders can be sent to researchers interested in housing a colony.
